APPLICATION PROCEDURES

The Lamar Utilities Board (LUB is accepting scholarship renewal applications for 3 (3) \$700 scholarships for the 2024 fall semester. LUB will award one scholarship each to a qualifying 2023 Lamar Utilities Board Scholarship recipient.

• There will not be a matching contribution fund from the Arkansas River Power Authority. The total renewal scholarship amount is \$700 per recipient.

Upon selection, recipients will receive a letter confirming the \$700 award. It will be the student's responsibility to notify LUB of their ENROLLMENT for the fall semester to the college of their choice. Upon receiving proof of enrollment a scholarship check in the amount of \$700 will be sent to the finance office of the students named college.

Failure to enroll and/or provide proof of enrollment for the 2024 Fall Semester at the college of choice will nullify the student's claim to the scholarship.

ELIGIBILITY CRITERIA:

Applicant must be a 2023 Lamar Utilities Board Scholarship recipient who resides with a family receiving electric service from LUB. The Scholarship Coordinator will only consider applicants who have fully completed the application process by the published deadline of **July 26, 2024.**

APPLICATION PROCESS:

- 1. Completed 2024 scholarship renewal application form.
- 2. Submit an official copy of your post-secondary course work including GPA. A minimum GPA of 2.5 is required.
- 3. Personal statement addressing some of your college involvements, personal high points from the previous year of schooling and the benefits that the Lamar Utilities Board scholarship provided.
- 4. Provide one (1) letter of recommendation from a current college instructor or professor.
- 5. Proof of electric service provided by City of Lamar Utilities Board (Lamar Light and Power).

SELECTION PROCESS:

Lamar Utilities Board Scholarship Coordinator will review and evaluate all completed applications that meet process requirements including the **July 26, 2024** deadline.

APPLICATION DEADLINE:

July 26, 2024. Send or hand-deliver completed application forms, including each of the required elements from the application process, to:

To be considered, an application MUST be received by 4:00 p.m. on or before July 26, 2024.

SELECTION NOTIFICATION:

Students selected for the LUB 2024 College Renewal Scholarship will be notified in writing by August 2, 2024. At that time, further instructions on the award process will be outlined.
